

Brother VyrL W. Justice, 33°



VyrL Wesley Justice, 33°, was born May 27, 1920, in Johnson County, Iowa, and attended Iowa City Schools. In 1939 he enlisted in the 113th Cavalry, and landed on Omaha Beach. He participated in the battles of Normandy, St. Lo, Mountain Domfront, Franconville, and Court Stienna as a member of a machine gun squad, and was wounded at Court Stienna. VyrL and Martha Kempf were married on December 29, 1945, and embarked on nearly 62 years of life together.

VyrL and Martha moved to Cedar Rapids in 1953, and in 1961 he established the company that bears his name, Justice Electric. An expert electrician, VyrL was also an excellent businessman, who believed that treating his customers and employees fairly and honestly was the best way to maintain an active and growing firm. Justice Electric

continues that tradition today, as one of the leading electrical contracting firms in Linn County.

Brother Justice first knocked on the door of Freemasonry at Crescent Lodge No. 25 in Cedar Rapids on June 14, 1954, when he was Initiated as an Entered Apprentice. He was Passed to the Degree of a Fellowcraft on September 20, 1954, and Raised to the Sublime Degree of a Master Mason on October 18, 1954.

He became a Master of the Royal Secret, 32°, in the Scottish Rite Valley of Cedar Rapids on November 10, 1955, as a member of the Merrill Coburn Memorial Class. He was invested with the rank and decoration of a Knight Commander of the Court of Honour on October 4, 1999, and coroneted an Inspector General Honorary, 33°, on December 3, 2005.

Brother Justice laid down the working tools of this life on October 8, 2007.

Brother Justice was a quiet, diffident, and even shy man, but one blessed with an abundance of patriotism, great love of family, and complete dedication to every cause to which he directed his considerable energies. His unshakable integrity was a model and example for all who knew him.

A long-time member of St. Paul's United Methodist Church in Cedar Rapids, he served on many boards and committees over the years. He was a founder of Cottage Grove Place in Cedar Rapids, served on the St. Luke's Hospital Foundation Board, and was Chairman of the Cedar Rapids United Way Campaign in 1978.

In addition to his fifty-year membership in Crescent Lodge and the Cedar Rapids Scottish Rite Bodies, Brother Justice was a member of Malta Chapter no. 415 of the Order of the Eastern Star, and of El Kahir Shrine.

Those of his Brethren who knew Brother Justice miss his quiet good counsel, his engaging and accurate wit, and his ready smile. He was an exemplar for other Masons, a Brother who went quietly about the cause of serving his fellow human beings with the goal of making his community better, rather than of receiving personal acclaim and honors. He is an excellent role model for the members of this Reunion Class.

Rest gently, dear Brother, until that time when we shall all sit together again in that Grand Lodge Above, eternal in the heavens.
